#### Here are Three Key Volunteer Opportunities

The League of Women Voters (LWV) is an action-oriented organization that attracts action-focused members, partners, and allies. As we enter the new League year of 2022-2023 the Lane County LVW needs volunteers to lead, participate in and support our action-based education and advocacy work. All League activities including voter services, studies of issues, advocacy, membership, administration, and office work are done by League volunteers.

As continuing board president Charlcie Kaylor said in her introduction to the May Board of Directors meeting: "Thanks to you all who do the important work of educating voters and working to create a more perfect democracy." Thank you to those members who served the last year as members of the Board of Directors, Committee Chairs, active committee members, and League office volunteers. Thanks go, too, to those who continued as Board Directors and Committee Chairs and to those who are new in their leadership roles for year 2022-2023.

There are still have three major committee chair vacancies in leadership roles for the coming year. Those vacancies are Program, Membership, and Units. These committee chair positions may serve as members of the Board of Directors or may report to the Board of Directors but not serve directly as a member of the Board.

Program Committee Chair - "Program is the reason for being, the basis for both advocacy and education efforts," from *League Basics*, LWVUS. The Program Committee helps organize agreed-upon studies of community concern and formulates positions for action and advocacy. *Linda Ferdowsian* has served as chair and is offering to continue to serve on the committee and mentor the next chair. This is a two-year position that runs from July 1, 2022, to June 30, 2024.

Membership Committee Chair - The Membership Committee is the life blood of the League. : The main duty of the Membership Committee is to plan and conduct membership recruitment and retention activities. The committee is responsible for two member events, the Fall Luncheon (September) and a mid-year event. The main duty of the Membership Chair is to coordinate, inspire and support committee members. It is essential to have an active committee and regularly recruit new members. The league's commitment to developing a diverse membership is a major challenge to the Membership Committee. (Source: LWVLC 2002 lob Description.) Former Chair, Karla Rusow and continuing members of the committee have agreed to serve as mentors to the new Chair. This is a two-year position that runs from July 1, 2022, to June 30, 2024.

**Units Coordinator** -- Unit meetings are regularly scheduled, fact-based, small group discussions around specific topics where members have an opportunity to listen, discuss, and possibly change opinions. Discussions at Unit meetings help form League positions on certain issues. Unit meetings are referred to by some as the "Heart of the League." The Unit Coordinator is responsible for informational "briefing" held the week before the units meet, to prepare coordinators and discussion leaders. The unit topic study committee provides a discussion guide. The coordinator is responsible to collect, correlate, and report to the Board the results of the Unit meetings discussions. League advocacy positions from these reports. Former Units Coordinator Mary Keating has volunteered to work with the new Coordinator during this transition.

For the May primaries this year the Voter Service Committee continued our collaboration with the Springfield City Club on candidate forums for state, county and local positions. This year we also developed a collaboration with the Siuslaw Public Library District to run an additional county commissioner candidate forum for the West Lane position and independently ran a forum for county assessor. Hopefully these efforts to expand our scope across a larger area of the county and a different demographic will increase the number of people can reach and inform.

We also continued to provide voter registration forms for senior centers, homeless shelters and schools and Anyone interested in joining the Voter Service Comthis year we developed a poster for

Vot411.com that could be put on bulletin boards in libraries, schools, senior centers and homeless shelters. It uses a QR code for the website which may increase use by younger adults who tend to use them more than older adults.

Compiling candidate information for Vote411 has continued to be a major effort during both election seasons as the website's usage has increased statewide. We continue to get other voter information for the election out to our membership and the public. Our speaker's bureau chief recorded talks for ballot initiatives that were posted on our webpage for members to watch.

#### RETHINK REUSE REDUCE RECYCLE OREGON'S PLASTIC POLLUTION AND RECYCLING MODERNIZATION ACT BY TERRY PARKER, ACTION CHAIR

Oregon's Department of Environmental Quality (DEQ) is moving ahead with the implementation of the Plastic Pollution and Recycling Modernization Act. From evaluating materials for possible inclusion in statewide recycling lists, consulting with a newly formed Technical Work Group and hiring a contractor • to conduct the field work for a new comprehensive solid waste composition study. DEQ notes that there will be five main parts to the study:

- 1. Composition of waste at disposal sites in Oregon
- 2. Rigid plastic resin identification
- 3. Residential food and organics collection composition in Deschutes, Lane, and Marion Counties
- 4. Inbound commingled recycling study
- 5. Outbound commingled recycling sorting study

As has been true for all past waste and recycling composition studies, this study will only be possible through immense assistance from disposal sites, collection companies, and recycling processors. DEQ expects to begin field work for the study in July 2022. For more information, including detailed descriptions of the five parts, visit our waste composition webpage.

How about sponsoring a political trivia game at a local pub?


#### **TALK TO ME**
