# OUR MISSION IS UNCHANGED by Linda Lynch, President



Election day has come and gone, but the fatigue remains. The Voter Service report reads like the

Twelve Days of Christmas, with many ballot measure presentations, including two in Florence, the gubernatorial debate, a booth at the Home Show and 1500 Voters' Guides - all gone. Plus, the League of Women Voters of Oregon was highly visible in the Yes on Measure 97 campaign. Not every member or League supporter was happy about that, but that issue provided us the opportunity to discuss our dual roles of education and advocacy.

Perhaps not surprisingly, a wide range of emotions has

followed election day. Also not surprisingly, the League's high visibility lingers. Almost every day since election day, the League has received emails of inquiry about joining, volunteering, holding events in the evening, suggestions for teen and young 20-somethings involvement. Almost, Every, Day, Clearly, energy around the election remains even if there is fatique among some. The emails are from people who want to join a progressive organization that is taken seriously and one which works to inform voters. Sounds simple enough, but we all know it is not that easy.

If you were a Clinton supporter, first take time to grieve. If you were a Trump supporter, first take time to be happy. Then, get back to work! Our work is as important next month as it was last month. It is even more important as a new administration without government experience forms.

We will continue to

- study issues
- respect various opinions on those issues
- value critical thinking
- reach consensus to create fact-based policies
- register voters
- lobby the legislature, Congress and local decision makers
- write letters to the editor
- provide forums for the public to learn how decisions affect their lives
- raise the voices of those least heard, and more!

One thing each of us probably needs to work harder to achieve is to understand our own personal bubbles. That phrase - personal bubble has developed recently to describe the small world we make for ourselves, individually. It is our family, the news we read and listen to, our regional identity, our friends, where we shop, where we work, where we play. The League of Women Voters is an excellent vehicle for learning how

people we don't know think, for learning how other electoral and government systems work, for at least looking outside our own comfort zones. If we are to continue striving for a more perfect democracy, we have to learn how others perceive their world, their bubbles.

December units are where we examine League positions and consider new topics. It's the perfect time to think about what the League can or should do in the coming year or two. Where should we place our emphasis? How are we going to engage the young people who are writing us?

The League is a political organization. We encourage informed and active participation in government. We influence public policy through education and advocacy. That is our mission. It is unchanged.

Again, thank you.





In her remarks as she accepted the Annabel Kitzhaber Award, Janet Calvert mentioned someone most members have probably never heard of: **Phyllis Montgomery.** 

Janet said, "When asked why I have been involved in League for so long, I remember Phyllis Montgomery, a woman of unmatched intellect and determination who knew lots about taxes. My first leadership role in League was chair of the tax committee, and she was a member. I was overwhelmed, scared and intimidated. She was encouraging and kind. I asked what kept her going, and she replied that League members like to

be 'where the action is'. That is still true."

Phyllis Montgomery (1910-81) moved to Eugene in the early 1940's, when her husband accepted a position at the University of Oregon in the speech department. She joined what was then the Eugene League a few years later and was president from 1951-53. She went on to become president of the League of Women Voters of Oregon from 1959-63 and then to the national League board to serve as secretary and treasurer from 1964-70. She is, thus far, the only member of our League to serve on the national board.

## Springfield 2030 Comprehensive Plan

The League submitted comments on October 13 regarding the proposed expansion of the urban growth boundary (UGB) in the Mill Race and North Gateway areas. The League requested that the staff do a detailed analysis of and respond to the issues raised by citizens about available land within the existing UGB for commercial/industrial purposes and the process that had eliminated the Seavey Loop area from consideration. The city staff prepared an extensive technical report that addressed the issues raised and concluded that the existing proposals for UGB expansion were appropriate and in keeping with state land use laws and regulations. At a joint meeting of the Springfield City Council, the Lane County Board of Commissioners, and the Lane Planning Commission on November 7, the three bodies moved the proposal forward for final adoption in early December.

#### **Envision Eugene**

The Eugene City Council at its meeting on October 24 approved two strategies to accommodate about 1600 multi-family homes within the existing urban growth boundary. This action provided the last direction needed for the staff to prepare all the legal documents and findings necessary for the City to adopt a new UGB and appropriate urbanization policies. The documentation is expected to cover about 1000 pages. The Eugene Planning Commission began its review in November and public hearings will be held in 2017. The League continues to follow this many-year process and will likely testify one last time in 2017.

## Jarrett Walker presentation

Nationally recognized transit consultant Jarrett Walker will make a presentation November 30 entitled "Abundant Access - Public Transit as an Instrument of Freedom." Walker will describe the principles that allowed him to successfully redesign the Houston transit network to provide better routing and more frequent service with the same resources. The League is a co-sponsor of the free event to be held at the Downtown Athletic Club beginning with a reception at 4:45 pm. (See page five.)

Fifteen people from eight countries became citizens in the court of Judge Thomas Coffin on November 18. Judge Coffin focused his remarks on the protections granted citizens in the legal system, including the need for a warrant from an unbiased source, a judge, before a search of one's home, protection from self-incrimination, the right to a jury trial and the right to counsel. He asked each new citizen to introduce themselves and tell where they are from. The country drawing the gasp of surprise from the audience was Myanmar. The ceremonies are always interesting; the different judges approach the ceremony differently; there is always some emotion that I think the new citizens did not expect to feel.

## Statement on Election Night Results

Washington, DC – The League of Women Voters president **Chris Carson** released the following statement on Tuesday night's election results:

"The League of Women Voters congratulates the American people for turning out to participate in our democracy.

"Unfortunately, in too many cases, voters had to overcome significant barriers that were erected by elected officials and other political operatives. These ongoing threats to voters' rights are unacceptable.

"This is the first presidential election in 50 years without the full protection of the Voting Rights Act. Thousands of eligible voters were purged from the rolls. Onerous voter ID laws prevented eligible voters from casting their ballots. We saw cases of misinformation and intimidation at the polls.

"We can and must do better. All year the League has worked in more than 700 communities, in every state, to register and help eligible Americans get ready to vote. In the 2016 election, more than 4 million people used our digital voter resource, VOTE411.org to find the election information they needed.

"The League of Women Voters will continue our work to expand participation in the election process and work to give a voice to all Americans."
