To register to vote, a person must be a resident of Oregon, a US Citizen and 16 or older. A voter must be 18 at the time of the election to vote. Registration online is available at www.oregonvotes.gov. Mail-in registration forms are available at Lane County Elections. Information on precincts, wards or voting districts is available at Lane County Elections.

Registration forms must be postmarked or received in the Lane County Elections Office by 4 pm on the 21st day before an election or by 11:59 pm online. Re-registration is necessary if a voter changes name, address, or party affiliation. Voters may register in a political party or may register as “not a member of a party (unaffiliated).” For the primary election, unaffiliated voters will receive ballots only for measures and non-partisan candidates. In the general election they are eligible to vote for party candidates. Elections in Oregon are conducted by mail. Ballots are mailed to registered voters 18-20 days prior to an election. Ballots must be received at Lane County Elections or an Official Ballot Drop Site or any Oregon Election Office by 8:00 pm on Election Day.

Election dates unless otherwise mandated by the legislature

- Second Tuesday in March
- Third Tuesday in May (Primary election in even-numbered years)
- Third Tuesday in September
- First Tuesday after the first Monday in November (General election in even-numbered years)
