
THE LEAGUE HAS YOUR BACK!

It is good to be home on solid ground. While I was off 2026 elections. on another sailing sojourn, your local League was hard at work. Kudos to all! We have a new, improved website that you must check out, if you haven't already. You will find our online Calendar and What's Happening list gives you up-to-date actions and news at your fingertips. Volunteers have been out-andabout all summer long. Members are registering, office hours are being covered, and studies underway. Your Observer Corps is in the room at meetings and reporting back through Sunshine Reports. Behind the scenes there are board meetings, program arrangements, recordkeeping, financial management, and more. INSPIRING!

At the State, as of September 1st, Oregon's LWV has a new president, Mark Kendall. As he takes the helm Mark says;

It is with humility and honor that I have accepted this opportunity to coordinate the efforts of and provide leadership for the League of Women



Voters of Oregon. As a League colleague said, these are "very unprecedented times." My motivation is derived from concern for the viability of our democratic system of governance, seeing decades of progressive social reform overturned and looking into the eyes of my 12-year-old granddaughter as I see her civil rights being eroded and abridged on a daily basis. This unconscionable transformation of our democracy must not stand. It is contrary to the League's core principles and adopted positions.

The National League is working on our behalf to counter threats to voter access and rights. Here are a few excerpts from the LWVUS Legal Center:

Today [Sept. 15, 2025] the League of Women Voters, League of Women Voters of Texas, and other nonprofit, nonpartisan civil rights and racial justice organizations, led by the Legal Defense Fund (LDF), filed an amicus brief in support of the plaintiffs' motions for preliminary injunction in *League of United* Latin American Citizens, et al., v. State of Texas, et al. The brief argues that the court should block Texas's newly enacted and racially discriminatory 2025 congressional map from going into effect before the

LWV Legal Center - Amicus Brief Texas

LWV of Washington, Campaign Legal Center, the Brennan Center for Justice, and Fix Democracy First filed an amicus brief in the Washington Court of Appeals defending the state's disclosure requirements for online political advertising. LWVWA and its coamici urged the court to affirm a Superior Court judgment penalizing Meta for failing to obey the requirements.

LWV Legal Center - State of Washington

LWV of New Hampshire and partners filed a federal lawsuit in New Hampshire challenging HB 1569, a new law that imposed documentary proof of citizenship to register to vote and abolished the option for voters to sign a sworn affidavit that would allow them to vote when their eligibility was challenged at the

All this and so much more. Recently the US Citizenship and Immigration Services (USCIS) updated their policy by barring groups like the League from providing voter registration services at USCIS-run naturalization ceremonies. Fortunately for us here in Lane County, Leagues can still register new citizens at ceremonies conducted by federal courts.

Of special note, LWVUS is joining No Kings 2 as a national partner. No Kings 2 is a planned mass protest against the Trump administration, scheduled for October 18, 2025, aimed at opposing perceived authoritarianism and promoting democracy:

LWVUS has decided to become an official partner for this day of mobilization to stand in solidarity with partners and stand up against hate and authoritarianism. The League has consistently and boldly spoken up in the face of rising authoritarianism. This is an opportunity to put words into action and show up in defense of democracy and as an effective ally. We **encourage Leagues to join locally** and participate in activations with partners on the ground in a nonpartisan manner.

We will post information on the LWVLC website about local No Kings 2 events as it comes available.

LANE COUNTY SPECIAL ELECTION IN NOVEMBER

November 4th will be a special election for some voters in Lane County. Four measures were filed with the County Elections office:

City of Springfield 20-371 Five Year Fire and Life Safety Services Local Option Levy.

Approval of this measure replaces Springfield's expiring \$0.38 local option levy, which ends June 30, 2026, with a \$0.53 levy to fund fire and life safety services. The levy would maintain the current level of emergency medical, rescue, and fire response, including staffing and operating the City's five fire engine crews. Each crew is staffed by fighter-paramedics who its level of services to the community. respond 24/7 to emergencies across Springfield.

Funds from this levy would support personnel, training, safety equipment, emergency dispatch, and other operational costs. The increased rate reflects inflation and the rising cost of maintaining these essential services.

If the measure fails, the City would lose funding for one of five engine crews. This would likely result in delayed emergency medical care, reduced capacity during peak call volumes, and fewer available units for medical and fire emergencies.

The levy is based on assessed (not market) property value. A typical Springfield home with an assessed value of \$189,000 would pay approximately \$100 per year. The levy would apply for five years, beginning in Levy for General Operations. fiscal year 2026/27.

South Lane County Fire & Rescue 20-372 Five-Year Local Option Levy for General Operations.

South Lane County Fire & Rescue provides fire and safety services within the territory of the Fire District 24/7 via a combination of paid professional staff and trained volunteers. In November 2022, the voters approved the Fire District's request to renew a local option levy of \$0.47 originally approved in 2012 for operations and staffing necessary to meet increased fire and ambulance call volume. The current levy expires in FY 2027/2028.

If adopted, starting in fiscal year 2026-2027 this measure would replace the existing levy of \$0.47 per \$1,000 of assessed value with a new levy of \$0.94 per \$1,000 of assessed value.

The new levy will allow the Fire District to meet increased costs and call by funding the purchase and staffing of a third District ambulance. The new levy will also allow the Fire District to continue funding other services, apparatus replacement, facilities maintenance, and equipment replacement. Without the levy funding, the Fire District will need to reduce

City of Dunes City 20-374 Measure Proposing an Amendment to the Dunes City Charter.

The Dunes City Charter is the governing document for the City of Dunes City. This measure would revise Chapter VI, Section 30 of the current Amended City Charter, adopted November 4, 1980. The proposed revision would amend the current language of Chapter VI, section 30 to include the following sentence, "Such petition shall be signed by not fewer than 20 electors or be accompanied by a fee of \$20." This change would allow candidates to either submit signatures or pay a fee to run for City Council positions.

Lane Fire Authority 20-375 Five-Year Local Option

The measure would authorize Lane Fire Authority (District) to impose a general operations tax levy at the rate of \$0.55 per \$1000 of assessed value on real property located within the District beginning FY 2026-2027. If passed, the District will use the tax revenue to hire two full-time firefighter/medics and place living quarters in the South Battalion response area. This increase will help to ensure faster response times, better coverage and reduce wait times throughout the District.

CHANGES ARE COMING TO NATURALIZATION CEREMONIES BY RUTH SEEGER, MEMBERSHIP CHAIR

Changes Are Coming to Naturalization Ceremonies. On August 29, 2025, the U.S. Citizenship and Immigration Services issued a Policy Alert (PA-2025-21) notifying Americans that: "...only state and local election officials will be permitted to offer voter registration services at the end of administrative naturalization ceremonies." With respect to nongovernmental organizations, the Policy Alert goes on to state: "USCIS is discontinuing the practice of permitting their attendance at naturalization ceremonies."

There are two types of naturalization ceremonies. One newest citizens and offering information and assisis Administrative; the other is Judicial. Our ceremonies in Eugene are Iudicial.

This recent message is from LWV President, Dianna Wynn:

"In my last League Update message, I shared news about the updated US Citizenship and Immigration Services (USCIS) policy barring groups like the League from providing voter registration services at USCISrun naturalization ceremonies. This new decision not only prevents us from carrying out our mission work but is a blatant attempt to keep new citizens from accessing their full rights. Leagues can still register new citizens at ceremonies conducted by federal courts. While the USCIS guidance harms our ability to register voters at many naturalization ceremonies. we are committed to ensuring all new citizens can register to vote.

We plan to continue our tradition of welcoming our tance on voter registration and voter information. Please see article below for more information.


