LEAGUE PARTNERS WITH COMMUNITY SUPPORTED SHELTERS

In 2024, the League was invited to meet with the staff tured the meetings of Community Supported Shelters (CSS) to design a process for the residents in the 13 Safe Spot communities which are run by CSS to register to vote and receive their ballots. These communities are the ones with Conestoga huts and are located from Northwest Eugene (Bertelsen) to Southeast Eugene (Hilvard and 34th). Ruth Seeger and Nancy Mills participated in the training for the staff so they could provide voter education to residents of each site.



With Ruth's involvement, Nancy and Peggy Dame again worked with Community Supported Shelters to provide voter registration information and voter edu-

cation. This time, however, Nancy and Peggy were able to meet with residents at their sites. We struc-



as conversations to give them the oppor-

tunity to learn about the issues of concern to them. and the exchanges were very informative, both for the residents and for us. It was a rare opportunity to see the facilities available at the sites and to become acquainted with the residents.

The relationship that the League has established with CSS is a very important one. The unhoused citizens are often marginalized and left feeling that they are not really a part of society. Voting is a practice that shows that your voice matters, whether you are housed or unhoused. This outreach to a population that is often ignored is a gift to the League, and we are exploring ways to extend voter education to this population and, potentially more broadly to unhoused citizens.

WHY IS DISCUSSION GROUP (AKA UNIT) PARTICIPATION IMPORTANT?

- Learn what is happening within the League and your communities through announcements and discussion. Fellow members who are attending the unit meeting are often involved in projects and work that sheds new light on what is happening within our communities. Be aware and in the know!
- Research materials, summarized by the Program Study Committee, offer a look at all sides of the issue. References allow you to follow up and dive deeper on issues. Members receive this material with the Araus newsletter.
- Influence League actions and policy. The League must have a policy, based in research, before it can speak out on an issue. This is one beginning step. The process of adopting a policy takes time as it moves through many steps.
- Prepare for fact-based informal discussions with friends, family, and your community. The League and, through extension, League members are respected because of their fact-based policies. (Members can speak for themselves as individuals. Only the League president or their approved representative can speak in an official capacity for the

League.)

- Support the League and fellow League members by participating in activities that are a result of their time, skill and a quest or learning. Lend your support through working on committee projects and participating in activities. Everyone in League of Women Voters of Lane County is a volunteer. Let them know you believe their time and effort is valued through vour participation!
- Discussion Groups (Units) meet monthly. Each group discusses the same study topic of the month. Six different meeting times are offered each month to accommodate your schedule.
- Meetings last up to two hours. You can attend the same location each month, choose a different location each month or attend multiple locations each month. Times and locations are listed in the *Argus* newsletter. Guests are welcome to participate in respectful, fact-based discussion.

THANKFUL AND CARRYING ON

I am thankful for every new and returning member as you step up to be a part of something bigger than yourselves. Committing to "just doing something" to defend democracy, whatever that means to you, is to engage in the fight to support our democratic ideals and process. To you who have been active for over fifty years, we honor you. We owe you much. Not only did you lay the foundation of who we are, you continue to lead. Thank you for your good counsel and enduring dedication.

Election Heroes Day is Monday, November 3rd. Take a moment to thank those who work tirelessly to ensure elections are secure and fair.

Lane County Elections, a division of the County Clerk's office, is charged with voter registration and administration of federal, state, and local elections within Lane County. The Elections team is committed to conducting Fair, Accessible, Secure, Transparent, Equitable, and Reliable (F.A.S.T.E.R.) Elections.

Lane County Elections

One year ago, the League of Women Voters of the United States President Dianna Wynn and CEO Celina Stewart released the following statement on the 2024 election results. It bears repeating:

We know how hard League members worked to empower voters in this election, alongside other activists in pro-democracy and civil rights spaces. The success of the democratic process is a testament to their tireless efforts. As LWV's CEO Celina Stewart, Esq., and I said in our joint statement on November 6, "We are thankful to Leagues across the country...as well as every election worker and democracy defender who guaranteed our fair and free voting process."

While we celebrate a fair and secure election, the outcome of this election has made the future for women unclear. Given the disturbing rhetoric made during this election season, we are deeply concerned about challenges we may face, particularly regarding the issues that disproportionately affect women, from health care and reproductive rights to economic security and equal representation.

The League does not endorse candidates, but we have always engaged in political advocacy. The election is now over, and those who were elected are no longer candidates. As a nonpartisan organization, the League has every right to call out statements, actions, and policies that are counter to our values and principles.

The League is an expert in nonpartisanship with over a century of experience in pro-democracy work. Navi-

gating through a hyper-partisan political environment in a nonpartisan manner can be confusing to some. Despite what political parties may have you believe, issues are not inherently partisan. Of course, political parties take partisan positions on issues. But that does not alter the League's nonpartisan approach.

Advocating for gender and racial equity is not partisan. Calling out attacks on democracy is not partisan. After all, our mission is to "defend democracy." We cannot live up to our mission if we are unwilling to speak up and speak out.

Game on! Now more than ever.

While the onslaught of news coming out of this administration can be "just too much," I encourage you to resist the temptation to shut down or tune out but, rather, focus and lean in on what you can do.

The LWVLC's Sunshine Reports represent hours of volunteer time sitting in meetings, hearing the deliberations of our elected officials, and then summarizing so that you can be informed. Please share. Pass on these reports. Use them as a springboard for personal interactions with your elected officials. Really get to know who represents you. Call them to task if you disagree and remember to give a shout out or virtual high five when you agree.

In his September 20 column in *The Register-Guard* local government reporter Alan Torres asked the question, "From City Councils to town halls, what is it you want to know?" Here is someone else who spends a lot of time in meetings asking for your opinion. Let him know:

- Have you used the services provided by the library, Community Health Centers, or fire department? What was your experience?
- Additionally, these issues have the potential to raise taxes. How have your finances been impacted by the government?
