## JANUARY'S UNIT DISCUSSION TOPIC - POSITION REVIEWS

In January, League members will undertake a comprehensive review of our local positions. This review aims to determine whether we should retain our existing positions, update information while keeping the core positions intact, restudy a position in light of new circumstances, or drop those that are no longer relevant. We may also consider creating new positions. Since advocacy can only be pursued based on the positions we hold, a rigorous process is followed before any new position is created or updated.

The position reviews will take place during our discussion unit meetings. To effectively manage the extensive number of positions, we divide the Lane County categories among various units, including government structure and process, economic policy, community development, governmental services, natural resources, and social policy. Each year, we rotate these categories, ensuring that all units have the opportunity to review all positions over time. The positions will be provided at the January unit meetings, an abbreviated version is located at the back of the League directory.

January is the time to submit proposals for informational studies for the 2026-2027 year. These studies lay the foundation for our unit discussions, providing

the deep, factual basis necessary for informed conversation and action. Proposals will be accepted throughout the month of January. Informational proposals will be reviewed by the Board, recommendations will be made, and topics will be approved at the annual meeting in May. Members will have the opportunity to volunteer for the research teams.

Please present the proposal(s) using the following sample format:

**Focus:** The impact of the Federalist Society and Heritage Foundation on our nation

**Scope:** To understand who they are, the principles they uphold, their goals, and the roles they have played in our political, judicial, and cultural systems.

Tobias Read is Oregon's 30th secretary of state. Born in Montana and raised in Idaho, he moved to Salem, Oregon, to attend Willamette University before earning his Master of Business Administration degree at the University of Washington. He brings a wide range of public-sector and private-sector experience to the office. He worked at the U.S. Treasury and Nike, Inc. prior to his election as state representative in 2007 and state treasurer in 2017.

As an elected official, Tobias has turned strong ideas and policies into real results that benefit Oregonians. He helped lead the charge to fund full-day kindergarten across Oregon, created and later implemented the Oregon Retirement Savings Program—now known as OregonSaves—which serves more than 130,000 Oregonians, and protected the Elliott State Forest by mak-

ing it one of the largest research forests and carbon reserves in North America.

As Secretary of State, Tobias' first priority is to hold the State of Oregon accountable for delivering on its promises, managing tax dollars wisely, and running secure, fair elections.

Tobias lives in Beaverton with his wife Heidi and their two children.

# OPPORTUNITIES TO PROTEST ICE ACTIVITIES

ICE continues to ramp up action in communities across the country. The League of Women Voters has positions that speak to many concerns related to ICE activities.

### Due Process

- As a nonpartisan, pro-democracy organization, the League is deeply alarmed by the ongoing ICE detentions, which too often fly in the face of due process and other fundamental rights.
- These actions undermine the democratic values of fairness, equal treatment under the law, and government transparency and accountability.
- The League supports due process for all persons, including the right to a fair hearing, right to counsel, right of appeal, and right to humane treatment.

### The importance of immigrants in our country

- Immigrants are part of the fabric of our communities — they make our country strong.
- Immigrants are your neighbors, co-workers, and fellow community members.
- All immigrants in our country deserve due process and fair treatment.
- "The League does not support deporting undocumented immigrants who have no history of major and/or violent criminal activity."

**Strong national partners** representing and defending immigrants include ACLU and LULAC. LULAC Oregon represents immigrant rights on a national and state-wide platform.

There are local organizations involved in these protests and several opportunities to join in solidarity with those being targeted by ICE. Vulnerable community members know about and appreciate these forms of support.

**Every Tuesday noon - 1pm, Singing for Our Lives** vigil is held on the corner of 7th and Pearl. A group of people, including guitarists, gather to sing songs of sorrow, hope, and resistance, and to share readings appropriate to these times. It is a peaceful gathering, without interference from ICE, and with support from passing motorists. The vigil always ends with "We Shall Overcome."

December in both Eugene and Springfield was the first in a series of monthly visibility actions as the community thinks deeply about **A Day Without an Immigrant**.

- Eugene, sign waving on the Ferry Street Bridge at noon
  - Springfield, at 5:30 pm with a vigil at City Hall
- These protests will take place every month leading up to May 1, which is International Workers' Day.

The next protest will take place on January 19.

## WANT TO DO SOMETHING?

If you are feeling the need to be involved in the upcoming elections, and I am sure that you do if you are a member of the League of Women Voters, Voter Service has opportunities for you. Voter Service has two aims: voter registration and voter education.

Both are equally important, and you might find an opportunity in either or both.

**Voter registration** is familiar: our goal for 2026 is to offer voter registration to groups who are underrepresented in voting rolls as well as to the general public. You might wonder why voter registration is important in a state with automatic voter registration. As part of our voter registration activity, we also help voters understand how to check their registration. If your address has changed, your ballot will be delivered to the old

address and can't be forwarded. A second important reason for checking your registration is to see if you are registered for a political party. You are not required to register, but in the primary election, you won't be able to vote in any partisan election; in 2026 this means races from US Senate down to state legislative offices. The number of voters who have not registered with a party is the second largest group of voters in Oregon. If a voter wants to have some voice in the people running for office, registering for a party is important and must be done before the

voting deadline of April 28, 2026 for the primary election. After the primary you can change your party, or leave it if you want.

**Voter education** is equally important because we need voters who are informed. There are a variety of activities that are in this area. Ballot measures are frequently hard to understand; League members write ballot measure explanations. We hold candidate forums so that voters can hear candidates respond to identical questions. Voter education is also important in creating the desire to vote. When you don't understand what is on the ballot, you frequently are less inclined to vote. And, in terms of making it easier for people to feel comfortable voting, we need folks to collect information for the digital voters guide, Vote411.

So you can see that there are a variety of opportunities. I have created a voter interests survey with descriptions of each type of activity and an opportunity for you to rank your top interests. That survey has an explanation of each activity and the time commitments. This has been sent to members expressing interest in voter services, but these opportunities are certainly available to every League member. You can find the survey at Voter Service Survey. ## WHAT LWVUS ACCOMPLISHED IN 2025

### 1. Launching Unite & Rise 8.5 in the Face of a Constitutional Crisis

In the wake of multiple actions from the Trump Administration defying Supreme Court orders, disregarding congressional authority, and ignoring democratic checks and balances, the League declared that our country is "in a constitutional crisis."

In response, LWV launched its Unite & Rise 8.5 initiative to engage and mobilize 8.5 million voters to protect and preserve democracy.

Unite & Rise supporters have taken action on many fronts, from the courts to the streets to the ballot box. Supporters showed up at rallies, raised their voices on critical issues like the occupation of Washington, DC, and the SAVE Act, and showed up at town halls and other civic events to speak directly to local politicians. You can join the movement and stay up to date on action opportunities by signing our Unite & Rise commitment form.

With "unite" in its name, this initiative created an opportunity to join forces with other people-powered organizations and leaders. LWV launched the Unite & Rise web series to share conversations between CEO Celina Stewart, Esq., and diverse leaders in the democracy space, including political scientist Erica Chenoweth, Young Voters founder Jahnavi Rao, and nonprofit leaders Sheila Katz and Reverend Shavon Arline-Bradley. In November, LWV the formation of an advisory committee made up of cross-sector leaders and Grassroots Power Partners from women-led organizations to further the initiative.

### 2. Empowering Voters and Election Heroes in the 2025 Election

Despite occurring in an election "off year," the 2025 races presented a critical opportunity to amplify voters' voices. While bad actors proposed bills that would suppress voters nationwide, LWV and its election-information resource VOTE411.org worked to ensure that as many people as possible had the information

and access necessary to cast their ballots.

This involved many first-of-their-kind outreach tactics, including our first national tour with the feminist singer and activist Cyndi Lauper. Leagues nationwide registered voters and promoted VOTE411 as a resource in the “charity villages” Cyndi set up across her US tour stops.

Leagues also engaged in their hallmark work, including registering voters, hosting candidate debates, and performing state and local election outreach, among other activities.

*Through VOTE411 alone, LWV provided 2.09 million voters with election information.* This covered 34.7k general election candidates in 15.8k general election races.

Voters weren’t the only people LWV supported. In 2025, the League became the managing partner of the civic holiday Election Hero Day, which recognizes the work of election staff and volunteers to keep our democracy running. As the US faces a poll worker shortage, LWV is proud to be a loud advocate for our election heroes.

### 3. Suing the Trump Administration

In March 2025, President Trump signed an Executive Order claiming to protect the integrity of American elections by making several changes, including requiring documentary proof of citizenship (“DPOC”) to register to vote using the federal voter registration form. This change would not only be unnecessary, as non-citizen voting is extremely rare – but it would also be more likely to suppress voters than protect elections. It would also be illegal, as the President lacks the authority to unilaterally alter election procedures (powers that rest with Congress and the states).

LWV joined partners in writing a letter outlining the illegality of the Order and requesting that the Election Assistance Commission (EAC) not implement it. Then, in April, LWV and its partners filed a federal lawsuit, asserting that the Order violated federal law and seeking a preliminary injunction to block the Order from taking effect. *The court granted the League’s motion and blocked the EO on April 25, 2025.*

Then, in October, the court granted LWV’s motion to permanently block the executive order, forbidding the EAC from requiring documentary proof of citizenship for the federal voter registration form.

This decision was an enormous win for voters. As our CEO, Celina Stewart, Esq., said, “Today, the court sent a strong message to the Trump administration: our elections must be accessible to all citizens, not just the privileged few.” The League continues to fight unlawful DPOC laws in federal courts nationwide.

LWVEF v. Trump is one of many legal cases the League worked on in 2025. Another significant victory included the first-of-its-kind win in our case that focused on the use of AI to intimidate voters. LWV is also challenging

the Trump Administration in other ways, such as suing the US Citizenship and Immigration Services, US Department of Homeland Security, and other offices over abruptly enacting a new rule barring nonpartisan civic engagement groups from providing voter registration and promoting civic engagement at administrative naturalization ceremonies.

### 4. Standing Against the SAVE Act

Throughout 2025, LWV has remained steadfast in its opposition to the Safeguard American Voter Eligibility (SAVE) Act, which would require documentation of citizenship to register to vote. This is unnecessary, since voters in every state are already required to affirm or verify their citizenship before voting.

Policies like the SAVE Act are less about protecting elections than about silencing certain groups of voters, including new citizens, Black Americans, and women. Their proponents often capitalize on xenophobic, anti-immigrant mis- and disinformation, inspiring people with fear rather than facts.

LWV created a simple action alert empowering users to contact their representatives and ask them to oppose the SAVE Act. As of July 2025, more than 52k users had contacted their representatives through LWV tools on the SAVE Act.

The SAVE Act is currently awaiting a vote in the Senate. *Tell your Senators to stand against it today!* You can find additional action alerts around congressional interference in DC, the Equal Rights Amendment, expanding voting rights, and more on our Take Action page! Thank you to the hundreds of thousands of people who participate in these action alerts and petitions annually.

### 5. Rallying Around a Light for Our Democracy

Rallying in partnership with fellow activists is a grand tradition that LWV has participated in since its formative days during the women’s suffrage movement. Unsurprisingly, in a year as divisive as 2025, LWV engaged in rallies to bring the people together and inspire hope and collaboration.

In March, during the President’s address to Congress, Leagues nationwide hosted Light for Our Democracy gatherings to unite people in reflection, action, and solidarity. In the spirit of togetherness, LWV partnered with a diverse array of partners across the democracy rights movement, many of whom spoke at our livestreamed gathering in Washington, DC.

Light for Our Democracy set the precedent for a year of partnership in protest. From the Fight for Fair Maps rally to No King’s Day and beyond, *LWV stood alongside movement allies and everyday people to speak out for a fair and representative nation.*

# LEAGUE OF WOMEN VOTERS OF OREGON AND ACLU OF OREGON FILE AMICUS BRIEF TO DEFEND OREGON VOTERS' PRIVACY AGAINST JUSTICE DEPARTMENT'S PURSUIT OF SENSITIVE VOTER DATA

**Press Release / Last Updated: November 25, 2025**  
*The brief cites Oregon's strong privacy laws as protection for voters' data from the federal government*

**EUGENE, OR** - Yesterday, the League of Women Voters of Oregon (LWVOR) and ACLU of Oregon filed a "friend of the court" brief in *United States v. Oregon*, in support of Oregon voters' privacy and Oregon state privacy law. The brief opposes the United States Department of Justice's unlawful demand for disclosure of Oregon voters' private information, such as driver's license numbers and the last four digits of Social Security numbers. The League is represented by Campaign Legal Center and the Brennan Center for Justice at NYU Law. The ACLU of Oregon is represented by the ACLU.

"The League of Women Voters of Oregon is determined to protect the private data of Oregonians from the overreach of the federal government," said **Mark Kendall, president of the League of Women Voters of Oregon**. "We are proud to support our state's strong state privacy laws against the federal government's fishing expedition. The League will continue to protect our members and Oregon voters from this intrusion that erodes trust in the very institutions that we expect to uphold our highest democratic principles and values."

"The Department's actions are yet another attempt to misuse federal law to illegally collect confidential data for illegitimate uses," said **Caren Short, director of legal and research, League of Women Voters of the United States**. "Voters deserve to have confidence that their private information will not be taken for wrongful purposes, and the League is proud to stand up on behalf of Oregonians to ensure they feel protected as voters and citizens."

"Voting is a fundamental and constitutional right. And Oregon law protects the privacy of sensitive voter information. Across the United States, Oregon is proudly leading in the areas of democracy, voting access, and people power," said **Eri Andriola, litigation manager, ACLU of Oregon**. "It is critical that we fight to ensure that our data and our right to vote are protected."

"The DOJ's demand for sensitive voter data not only threatens Oregon voter's privacy, it is a blatant attempt to stifle democratic participation in Oregon and nationwide," said **Theresa J. Lee, senior staff attorney, ACLU Voting Rights Project**. "As DOJ has already admitted publicly, this is not about Oregon's voter rolls, but about their attempt to gather sensitive voter data never before held by the federal government."

"What the US Department of Justice is doing in Oregon and in other states across the country is a blatant overreach by the federal government that seeks to violate voters' privacy and undermine their freedom to vote. Our Constitution is clear: The states and Congress — not the executive acting alone — have the authority to administer and regulate our elections, including over-

sight of voter data," said **Brent Ferguson, director of strategic litigation, Campaign Legal Center**.

"Oregonians should have confidence that their personal, private information is protected. Alongside our partners, Campaign Legal Center will continue to stand up against the Trump administration's unlawful data seizures."

"The Justice Department's lawsuit against Oregon is part of a dangerous attempt to amass sensitive voter information from across the country. This collection of sensitive data, like driver's license numbers and partial Social Security numbers, is the latest move in the administration's broader effort to undermine American elections," said **Eileen O'Connor, senior counsel, Brennan Center for Justice**. "A federal voter database of this scale could be exploited to fabricate false claims of fraud or remove eligible voters from the rolls. States have long defended voter privacy and election security, and the Justice Department's work to amass sensitive data on voters across the country threatens both."

*United States v. Oregon* is one of nine lawsuits the Justice Department has filed around the country demanding the disclosure of private voter data. Since May, the Department has asked dozens of states for copies of their complete, unredacted statewide voter file, including sensitive information such as driver's license numbers and the last four digits of voters' Social Security numbers. Oregon received a request on July 16, 2025. Because state law prohibits the disclosure of some of the data the Department requested — namely, a voter's birth month, birth day, Social Security number, and driver's license number — the Oregon Secretary of State offered to provide the publicly available voter file, provided the Department followed state laws in requesting it and agreed to comply with federal privacy laws. On September 16, 2025, the Department filed a lawsuit against the State of Oregon and the Oregon Secretary of State.
