WHO MAY NEED TO REGISTER IN OREGON?

- Voters who recently turned 18 (or will by the next election day)
- Voters who have moved recently
- Voters who have changed their name
- Voters whose signature has changed
- Voters who receive their mail at an address other than their residence.
- Voters who were recently released from incarceration
- New US citizens

Are you a citizen of the United States of America? Are you at least 16 years of age? If you mark no in response to either of these questions, do not complete this form.

One more question: Have you recently been released from incarceration?

You CAN vote in Oregon if:

- You were convicted, but have not yet been sentenced
- You have been released from incarceration, but on parole
- You were released from incarceration but required to wear an ankle bracelet

NOTE: After release from incarceration, you must re-register before you can receive a ballot

You can NOT vote in Oregon if:

- You are serving a sentence for a felony conviction in the county jail (not in prison)
- You are actively incarcerated for a felony in another state (not Oregon)
- You were convicted of a felony and are now on a work release program out on weekdays and incarcerated on weekends
- You are no longer in prison, but required to reside in a halfway house

- Why would I need to update my signature?
- Why do they need my phone and email?
- If I register to vote, will I have to do jury duty?
- Can I have my ballot from home mailed to my college address?
- Can I vote in my school's county rather than my home?
- How do I decide which party to join? Does it really matter?
- What if I don't want to vote by mail?
- What if my ballot is lost or damaged? Or if I make a mistake? Can I still vote?
- What if I want to register in another state?
- Can I vote if I'm homeless?
- What if I've been incarcerated?

PLANNING A VOTER REGISTRATION DRIVE

- Make sure you have supplies ready. (Voter registration cards can be picked up from your local Election Office, but they are limiting the number for each organization.)
- Work with at least one other person.
- Have a connected device with you.
- Start with, "Are registered to vote in Oregon?" Follow up with, "Do you need to update your registration?"
- Try to keep a count of the people you talk to.
- Definitely keep track of the number of registrations--online, paper, and the number of registration cards you give out. (Important for grant reports and renewals)
- Have LWV membership information available!
